- 3. How it Works:** During each of the seventeen (17) Participation Periods, Eligible Participants can earn cash rewards on a first come, first serve basis by participating as follows:

- a) MoneyGram Pit Stop:** the first two hundred fifty (250) Eligible Participants who complete the web submission form at <https://mghf1t.moneygram.com> the "MoneyGram Pit Stop" during the Participation Period will each receive \$25.

Cash Reward Disbursement:** Eligible Participants will be contacted within three (3) business days following each Participation Period via the email provided in their MoneyGram Pit Stop submission form to select a disbursement method for their cash reward, either (i) direct to bank account, (ii) in-store cash pickup or (iii) other online methods that MoneyGram may make available from time to time. Cash rewards will be made available within 14 business days of each Participation Period. **Eligible Participants must be opted-in to email and SMS marketing communications in order to be eligible to receive a cash reward.**
