

**Prize Draw Terms and Conditions for the MoneyGram Silverstone Dream Weekend. (“The MoneyGram Promotion.”)**

1. The Prize Draw is open to all entrants who are UK residents aged 18 years or over, except employees of the Sponsor, their families, agents or any third party directly associated with administration of the Prize Draw.
2. The Prize shall be for one winner plus their guest, If the guest is less than 18 years old at the time of the winning then the winner agrees to provide all consents and disclaimers applicable on behalf of the guest.
3. The Prize Draw is free to enter, and no purchase is necessary.
4. There are two ways to enter the Prize Draw. These are referred to as the “entry modes.” Only one entry mode per person is permitted.
5. Only one (1) Online Entry Form per person/email/mobile phone number permitted. In the case of multiple Online Entry Form entries from any one (1) person/email/mobile phone number, only the first entry received will be accepted and all subsequent entry attempts from such person will be void. Subsequent attempts made by the same individual to submit multiple entries by using multiple or false contact information, accounts or otherwise may result in the entrant being disqualified.

7. Entry Period: The opening date for entries is 00.001 GMT on 26<sup>th</sup> May 2024 The closing date of the Prize Draw is 23.59 GMT on 23<sup>rd</sup> June 2024 (the “Entry Period”) . Entries received after this Entry Period will not be valid.

10. A winner will be chosen by an independent third party on 26<sup>th</sup> June 2024 by 17:00 GMT (“Draw Date”). The Silverstone Dream Weekend Prize (“Prize”) will be offered during 4<sup>th</sup> July 2024 – Monday 8<sup>th</sup> July 2024.

  - a. Two (2) tickets for the British Grand Prix at Silverstone Circuit, including one day in the Paddock Club in the MoneyGram Haas F1 Team suite (to be chosen at the Sponsor’s sole discretion) and two days in the Farm Curve Grandstand; and
  - b. Four (4) nights standard hotel accommodations for two (2) adults. (the winner plus a guest) one room, double occupancy at the Delta Hotel by Marriott Northampton (“hotel”) from check in time on Thursday 4 July 2024 to check out time on Monday 8 July 2024; and
